Your application should also include your high school transcript and PSAT/SAT scores. The transcript should contain your class rank and cumulative GPA. A printout of the PSAT/SAT scores e-mailed to students will suffice.

The award recipients will be provided with the date and location of the meeting so that the recipients can reserve that date for themselves and their parents to attend as our special guests.
